Release and Waiver of Liability

Please Read Carefully. This is a Legal Document that affects your Legal Rights. This Release and Waiver of Liability (the "Release") executed on this _____ day of _____, 200__, by _____ (the "Volunteer"), and (in the case of a minor child) _____, the parent having legal custody and/or legal guardian of the volunteer ("the Guardian"), in favor of Homeward Ministries, an Alabama nonprofit corporation, their directors, officers, employees and agents (collective, "HM").

The Volunteer (and Guardian) desires that the Volunteer works as a volunteer for HM and engage in the activities related to being a volunteer (the "Activities"). The Volunteer (and Guardian) understands that the Activities may include construction and rehabilitating residential buildings, working in a HM warehouse, working on church property and at any point living in housing provided for Volunteers of HM. The Volunteer (and Guardian) hereby freely, voluntarily, and without duress executes this Release under the following terms:

- 1. Release and Waiver.** The Volunteer (and Guardian) does hereby release and forever discharge and hold harmless HM and its successors and assigns from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's Activities with HM. The Volunteer (and Guardian) understands that this Release discharges HM from any liability or claim that the Volunteer may have against HM with respect to any bodily injury, personal injury, illness, death or property damages that may result from Volunteer's work for HM, whether caused by the negligence of HM or its officers, directors, employees, agents or otherwise. The Volunteer (and Guardian) also understands that, except as otherwise agreed to by HM in writing, HM does not assume any responsibility for or obligation to provide financial assistance or other assistance, including but not limited to medical, health, or disability insurance in the event of injury or illness.

2. **Medical Treatment.** Except as otherwise agreed to by HM in writing, the Volunteer (and Guardian) does hereby release and forever discharge HM from any claim whatsoever which arises or may hereafter arise on account of any first aid, treatment, or service rendered in connection with the Volunteer's Activities with HM or (in case of a minor child) with the decision by any representative or agent of HM to exercise the power to consent to medical or dental treatment as such power may be granted and authorized in the Parental Authorization for Treatment of a Minor Child.

3. **Assumption of the Risk.** The Volunteer (and Guardian) understands that the Activities included work that may be hazardous to the Volunteer, including, but not limited to, construction, home repairs, home maintenance, yard work with powered and non-powered tools, loading and unloading, and transportation to and from work sites. Volunteer (and Guardian) hereby expressly and specifically assumes the risk of harm in the activities and releases HM from all liability for injury, illness, death, or property damage resulting from the Activities.

4. **Insurance.** The Volunteer (and Guardian) understands that, except as otherwise agreed to by HM in writing, HM does not carry or maintain health, medical, or disability insurance for any Volunteer.

Each Volunteer is expected and encouraged to obtain his or her own medical or health and auto insurance coverage.

5. **Media Release.** The Volunteer (and Guardian) does hereby grant and convey unto HM all right, title and interest in any and all photographic images, video or audio recordings made by HM during Volunteer's Activities with HM, including, but not limited to, any proceeds, donations or benefits derived from such photographs or recordings.

6. **Other.** The Volunteer (and Guardian) expressly agrees that this Release is intended to be as broad and inclusive as permitted by the laws of the State of Alabama, and that this Release shall be governed by and interpreted in accordance with the laws of the State of Alabama. The Volunteer (and Guardian) agrees that in the event that any clause or provision of this Release shall be held to be invalid by any court of competent jurisdiction, the invalidity of such clause or provision shall not otherwise affect the remaining provisions of the Release which shall continue to be enforceable.
